#### **PEDDLERS**

#### **Sections:**

4.04.010	License required

**4.04.010 License required.** It shall not be lawful for any traveling peddler or merchant to vend or offer for sale any goods, wares or merchandise, except provisions farm and garden produce, fish and game within the Town of Grandview until a license so to do has been first obtained. (Ord. No. 5, S1, No date)

**4.04.020 License fee.** The price of license under this Ordinance shall be as follows:

For traveling peddlers not less than one nor more than five dollars per day. No license shall be issued or granted to either for less than one day.

For sales at auction, twenty five dollars per month; and no license shall be issued or granted to either for less than one month.

Butchers' license for peddling meat one dollar per day. (Ord. No. 5, pt. S4, No date)

- **4.04.030 Procuring a license.** Any person or persons desiring to procure license under this Ordinance shall produce to the Clerk of the Town of Grandview the receipt of the Treasurer thereof for the price of such license, and the Clerk shall thereupon make out and deliver to the proper person a license for the time paid for. (Ord. No. 5, S5, No date)
- **4.04.040 Penalty for not obtaining a license.** Any persons doing any business, for which this Ordinance requires license, without first obtaining such license, shall be deemed guilty of disorderly conduct, and upon conviction thereof shall be fined in any sum not less than one dollar nor more than twenty five dollars for each offense, and cost of prosecution. (Ord. No. 5, pt. S6, No date)
- **4.04.050 Payment to Clerk for issuance of license.** When by any Ordinance the Clerk of the Corporation of the Town of Grandview is required to issue a license to any person for any purpose whatever, he shall be allowed the sum of one dollar, to be paid by the applicant on receipt of the license. (Ord. No. 5, S7, No date)

#### CIRCUSES, THEATERS, SHOWS

- **4.06.010 License required.** That hereafter it shall not be lawful for any person, persons or firm to exhibit for pay any animal menagerie or other collections of animals, show, circus, theater, museum or any public exhibition of any kind within the corporate limits of said Town of Grandview, until a license so to do has first been obtained. (Ord. 5, S2, No date)
- **4.06.020 License fee.** The price of said license for menageries ten dollars per day. For all other exhibitions, theatres, and shows other than menageries one dollar for each and every day such show or exhibition may continue and the amount desired therefrom put in Treasury. (Ord. unnumbered, May 5, 1890) (Ord. 5, pt. S4, No date)
- **4.06.030 Procuring a license.** Any person or persons desiring to procure license under this Ordinance shall produce to the Clerk of the Town of Grandview the receipt of the Treasurer thereof for the price of such license, and the Clerk shall there upon make out and deliver to the proper person a license for the time paid for. (Ord. 5, S5, No date)
- **4.06.040 Penalty for not obtaining a license.** Any person exhibiting any show, menagerie or circus, which this Ordinance requires license, without first obtaining such license, shall be deemed guilty of disorderly conduct, and upon conviction thereof shall be fined in any sum not less than one dollar nor more than twenty five dollars for each offense, and cost of prosecution. (Ord. 5, pt. S6, No date)
- **4.06.050 Payment to Clerk for issuance of license.** When by any Ordinance the Clerk of the corporation of the Town of Grandview is required to issue a license to any person for any purpose whatever, he shall be allowed the sum of one dollar, to be paid by the applicant on receipt of the license. (Ord. 5, S7, No date)

**4.10.010 Liquor retailer's permits issued under the laws of the State of Indiana.** Be it ordained by the Board of Trustees of the Town of Grandview, Spencer County, Indiana, that under the provisions of Section 12-517, Burns Revised Statutes, 1933, the Board of Trustees does now consent that liquor retailer's permits may be issued to applicants otherwise duly qualified under the laws of the State of Indiana in respect to premises located within the said Town of Grandview, Indiana.

**4.11.010 Keeping a disorderly tavern.** Every person who shall keep a disorderly or noisy tavern, coffee house or saloon within the Town of Grandview, shall be deemed guilty of disorderly conduct, and upon conviction thereof shall be fined in any sum not exceeding ten dollars nor less than one dollar for each offense and cost of prosecution.
